Good listeners focus on what they are hearing. They pause to think about what they've heard before responding. They ask questions because they want to know the answers. Not just to keep the conversation going.

4. So often, we are distracted with other things. We try to listen while continuing to work on the computer or watch television. To be fully present means we eliminate these distractions and focus exclusively on the other person. It takes great effort to be fully in the moment, leaning forward, eyes and heart open. Words are only the part of communication. Sometimes we need to experience the other person's feelings to really understand. We need to listen with our heart as well as our mind. We must repeat back what the other person has said. When we do this—and do it accurately—we communicate that we understand. It also gives us an opportunity to re-calibrate our understanding if we have misunderstood something. Plenty of people are good talkers, few are good listeners. If you develop the latter skill, you will find yourself invited into amazing conversations that wouldn't otherwise happen.


- The report estimated that ` 700 per vote was spent and on an average, nearly ` 100 crore per Lok Sabha constituency was spent in these elections.
- 3. The methodology for estimation was based on a PPE approach of enquiry, a method evolved by CMS for estimating

corruption in India over years. Key sources for the estimation included campaign activities by parties and candidates, voters' observation in elected constituencies, secondary data on demographic divides, field study and media coverage among others.

4. While CMS had estimated ₹ 30,000 crore as

poll expenditure in the 2014 elections the figure has doubled in the 2019 elections, making Indian elections as the costliest elections ever in the world.

The BJP spent about 20% in 1998 against about 45% in 2019 out of the total poll expenditure estimate. In 2009, the Congress' share was 40% of total expenditure against 15 to 20% in 2019," the report stated.
